Each author will be given detailed instructions as to the intended audience, as well as expected breadth and depth of coverage of the material in the hopes that this will minimize the problem of uneven coverage of topics and chapters that often occurs in edited books. Although each of the types of evidence covered in the book use methods of analysis that lie outside chemistry, these will be mentioned only for completeness in passing. The emphasis will be on the use of chemical tools in evidence analysis. This book is designed to be either a text book for an advanced forensic chemistry course, or a treatise in forensic chemistry for the scientist who wants to learn the subject in some depth. It is not designed to be a survey of the current literature in the field or a reference manual.

Fundamentals of Forensic DNA Typing is written with a broad viewpoint. It examines the methods of current forensic DNA typing, focusing on short tandem repeats (STRs). It encompasses current forensic DNA analysis methods, as well as biology, technology and genetic interpretation. This book reviews the methods of forensic DNA testing used in the first two decades since early 1980's, and it offers perspectives on future trends in this field, including new genetic markers and new technologies. Furthermore, it explains the process of DNA testing from collection of samples through DNA extraction, DNA quantitation, DNA amplification, and statistical interpretation. The book also discusses DNA databases, which play an important role in law enforcement investigations.
